Education and Research Goals

The education and research goals at this graduate school are to develop talented individuals who, with a basis in engineering, boldly take up the challenge of exploring unexplored fields and new technological innovations, contribute to the sustainability and development of human society, and who are able to acquire systematic knowledge regarding science and technology as well as an engineering-based thinking, and have the ability to solve social problems with an understanding of diversity and a broad perspective.

Admission Policy

- 1. Desired student profile
 - 1) Strongly motivated to study in accordance with the educational research goals of the Graduate School.
 - 2) In addition to advanced expertise in one's major field of study, possesses engineering and logical thinking skills as well as creativity, and has a strong desire to solve social problems.
 - 3) Possesses excellent communication skills, foreign language proficiencies, and sound ethics, respects diversity, and aspires to contribute to the international community.

2. Selection Policy

Applicants are selected through written and oral examinations, and submitted documents are evaluated based on the desired student profile. Academic records and foreign language skills are taken into consideration as well. In this selection process, emphasis will be placed on the following.

- · High level of expertise in field of interest, and deep engineering-based thinking skills.
- Ability to discover unknown problems and develop creative solutions.
- International communication skills and ability to disseminate research results through those skills.

1. Requirements for Eligibility

- (1) Those who have obtained, or are expected to obtain by March 31, 2026, a master's or professional degree from a Japanese university. (Note 1)
- (2) Those who have been conferred, or are expected to be conferred on or before March 31,2026, a master's degree by the National Institution for Academic Degrees and Quality Enhancement of Higher Education

(NIAD).

- (3) Those who have been conferred, or are expected to be conferred on or before March 31, 2026, a degree equivalent to a master's or a professional degree outside of Japan. (Note 2)
- (4) Those who have completed, or are expected to complete by March 31, 2026, a program in an educational institution in Japan that is designated by the Minister of Education, Culture, Sports, Science and Technology as providing the program of a foreign graduate school within the education system of a foreign country, and have been conferred or are expected to be conferred a degree equivalent to a master's or a professional degree.
- (5) Those who have completed or expect to complete a program at the United Nations University and have been conferred, or are expected to be conferred by March 31, 2026, a degree equivalent to that of a master's degree.
- (6) Those who have passed or are expected to pass by March 31, 2026, a screening for the fundamental ability for doctorate dissertation research as specified in Article 16-2 of the Standards for Establishment of Graduate Schools at a school outside of Japan, an educational institution mentioned in eligibility (4) above, or the United Nations University, and are recognized by this graduate school as having abilities at least equivalent to those who have a master's degree. (Note 3)
- (7) Those who have graduated from a Japanese university; or have completed at least 16 years of academic education outside of Japan and have been engaged in research at a university, research institute or other institution in Japan or outside of Japan for at least 2 years; or are expected to have been engaged in research for at least 2 years by March 31, 2026; and are recognized by this graduate school as having abilities at least equivalent to those who have a master's degree or a professional degree as a result of said research. (Note 1) (Note 2) (Note 3)
- (8) Those 24 years or older as of March 31, 2026, whom this graduate school has recognized, through individual screening of entrance qualifications, as having abilities that are at least equivalent to a master's degree or professional degree holder. (Note 4)
- Note 1) Japanese universities mentioned in Eligibilities (1) and (7) above are universities within the boundaries of Japan and as prescribed in Article 83 of the School Education Law.
- Note 2) Eligibilities (3) and (7) above include the case of having completed a correspondence program provided by a foreign school of said country while residing in Japan.
- Note 3) Those who intend to apply under requirement (6) or (7) above shall submit designated documents for the screening of their entrance qualifications to the Graduate School Team, Graduate School of Engineering Administrative Division (refer to 11. Contact) by November 5, 2025, as entrance qualifications are screened individually before submission of application. Please inquire at the Administrative Department of this Graduate School in advance about requirements for application and document submission.
- Note 4) ① Those covered under Eligibility (8) above, are those who are not covered under Eligibilities (1) through (7) above, and those who will be recognized by this graduate school through individual screening of entrance qualification as having abilities at least equivalent to that of a master's degree or a professional degree holder.
 - ② Those who intend to apply under requirement (8) above shall submit designated documents for the screening of their entrance qualifications to the Graduate School Team, Graduate School of Engineering Administrative Division (refer to 11. Contact) by November 5, 2025, as entrance qualifications are screened individually before

- submission of application. Please inquire at the Administrative Department of this Graduate School in advance about requirements for application and document submission.
- ③ Those who are recognized as having abilities at least equivalent to a master's degree or professional degree holder through screening of qualifications will be permitted to apply and to take the entrance examination.

2. Acceptance of Mature Students

- (1) Mature students are eligible for acceptance in each department. Departments shall accept mature students.
- (2) Persons currently working as full-time employees at companies, educational and research institutes, and other organizations may undertake studies in this doctoral program, concurrent with such employment.
- (3) Selection of applicants shall take into consideration factors including the applicant's master's thesis and related research achievements.

3. How to Apply

- (1) Applicants are asked to complete the entrance application form via the WEB Application System. (https://www.t.u-tokyo.ac.jp/en/study-at-utokyo/soe/apply/guideline)
- (2) All application documents must be uploaded online to a designated location. For details, check the Graduate School of Engineering website. (https://www.t.u-tokyo.ac.jp/en/study-at-utokyo/soe/apply/guideline)
- (3) Application period: From November 28 (Friday) until 3:00 p.m., December 4 (Thursday), 2025 (Japan time) [Be on time]
- * However, for "Other" in "Documents for Submission," refer to the "Guide to Entrance Examinations" of the department to which the application will be sent, as the submission method or period may differ.

4. Examination Dates and Locations

Examinations will be held between mid-January 2026 and early February 2026. For details on days, times and locations, refer to the "Guide to Entrance Examinations" and the website of the department to which the application will be sent.

5. Selection Methods

- (1) Selection shall be based on afirst stage examination and a second stage examination.
- (2) Selection for the first stage examination shall be based on submitted documents, a written examination, and an oral examination.
- (3) The first stage examination will involve a document screening based on the submitted application materials. A written examination, oral examination, and other assessments may then be administered exclusively to those applicants who successfully pass the document screening. Examination fees will not be refunded even if applicants do not pass the document screening. For details, refer to the "Guide to Entrance Examinations" of the department to which the application will be sent.
- (4) The second stage examination shall be in regard to the applicant's master's thesis or a related topic. The second stage examination will only be conducted for applicants who pass the first stage examination.

(5) Selection of students for admission shall be based on a comprehensive judgment, taking into account the written examination, the oral examination, submitted documents, the applicant's master's thesis and other related materials.

◆ Fees required for admission (tentative fees for 2026)

(These fees are not required for international students on scholarships from the Japanese government

(Ministry of Education, Culture, Sports, Science and Technology). In addition, no admission fee will be charged to students who are expected to complete a master's or professional degree program in a graduate school at the University of Tokyo.)

- 1. Admission fee: 282,000 yen (tentative fee)
- 2. Tuition fees: First term: 260,400 yen (Annual fee: 520,800 yen) (tentative fee)
- (Note) The amounts indicated above are tentative. If amounts are amended at the time of admission or while the individual is registered as a student, the new amounts shall apply from the time of the amendment in question.

9. Precautionary Notes

- (1) Applicants cannot apply to two or more departments in the Graduate School of Engineering at the same time. Those who have passed the first stage examination of the Application Schedule A of this Graduate School cannot apply for the Application Schedule B without first withdrawing their acceptance from Application Schedule A. Also, applicants cannot enroll in other universities or other schools at the University of Tokyo at the same time as the Graduate School of Engineering. First screening successful applicants for the Special English Graduate Program for 2026 intake are not eligible to apply. However, applicants who failed the first screening for the Special English Graduate Program for 2026 intake are permitted to apply.
- (2) Applications will not be accepted if all the required documents are not complete and in order by the submission date indicated above. After the application process is complete, no changes to documents will be accepted and no documents will be returned, under any circumstances.
- (3) The examination admission card will be issued through "My Page" of the WEB Application System around 3p.m. on December 23 (Tuesday), 2025. Print it out on your own and bring it with you on the day of the examination.
- (4) Those who wish to enter the university while still being employed are required to submit upon entry to the university, a Letter of Approval (in any format) from their employer (as long as the one who approves you holds a higher position than you, then the exact position does not matter) certifying that their "in office status" does not in any way interfere with them entering the university.
- (5) The University of Tokyo provides reasonable accommodations to ensure that individuals with disabilities, etc. are not disadvantaged during entrance examinations and studies after enrollment, and provides consultations for this purpose. Those who wish to request accommodations for entrance examinations and studies after enrollment should contact the office of the department where they are applying before application deadline (refer to 4. How to Apply). Although requests made after the above deadline will still be considered, it is recommended that applicants send their requests well in advance as it may not be possible to provide certain accommodations without sufficient preparation time. - (6) Applicants who have foreign nationality must have a visa that will allow admission to a Japanese graduate school, as stipulated in the "Immigration Control and Refugee Recognition Act (Law No. 319, 1951)," by the time of admission procedures.
- (7) Under some circumstances, application procedures, examination dates and way of conducting, and other details may be subject to change.
- (8) Once paid, examination fees will not be refunded under any circumstances.

- (9) After the admission process is completed, admission fees will not be refunded under any circumstances.
- (10) The University of Tokyo shall use the personal information obtained through the application process only for the purpose of ① Selection procedures, ② Notification of results and ③ Enrollment procedures. For those who enroll, this personal information and the examination results used for admission selection shall also be used for ④ Educational Affairs (school registration, attendance, etc.), ⑤ Student Support (healthcare, career support, application procedure for tuition exemption and scholarships, use of libraries, etc.) and ⑥ the Management of tuition payment.
- (11) The examination results used for admission selection may be used in future studies for the improvement of admission and education systems at the University of Tokyo.
- (12) In case of an unexpected situation such as a natural disaster, please note that information related to entrance examinations will be offered on the Graduate School of Engineering website.

10. Response to fraud

If any false statement or forgery is found in the application documents, or if there is clear evidence that there was any fraudulent activity during the examination, that student's admittance may be canceled even after enrolling in or going on to a graduate school.

The University of Tokyo has established the "The University of Tokyo Security Export ControlRegulations" in accordance with Japan's "Foreign Exchange and Foreign Trade Act", and rigorously implements security export control for potential students before and after their enrollment on the basis of these regulations. [About TOEFL scores]

- Applicants should submit an official TOEFL iBT/TOEFL iBT Home Edition score following the instruction of [How to submit TOEFL scores] below.
- Applicants should check the ETS website for information on how to apply, required equipment and examination environment of the TOEFL iBT Home Editon on their own.
- Foreign Language(English) exams of Graduate School of Engineering Entrance Examinations accept "Test Date Scores". We do not accept "MyBest scores".
- Applicants cannot submit score sheets from group testing systems such as TOEFL ITP. TOEFL ITP will not be conducted on the day of Graduate School of Engineering entrance examination.
- Applicants should submit TOEFL scores even if their native language is English.

- Master's Program Doctoral Program 【Application schedule A】 Scores are valid for Test Dates after September 2023.
- Master's Program Doctoral Program 【Application schedule B】 Scores are valid for Test Dates after February 2024.

1 Transmit your official TOEFL score

• Be sure to request ETS to transmit your score according to "Send TOEFL Institutional Score Report to" below through your ETS account when registering for a TOEFL test by the deadline of the department you wish to apply for. If you did not request ETS to transmit your score at the time of registration, please do so as soon as possible.

- If you have successfully requested for the transmission of your official TOEFL score and there is no problem during your TOEFL test, we should receive your score report data online about 8 days after you take the test. However, rescheduling of the test may occur due to problems with the network/equipment or there could be delays in issuing official scores due to other various reasons. Please plan ahead to allow ample time for taking the exam.
- It is possible to transmit your official TOEFL score before your application to our graduate school. Also, you don't need to transmit your official TOEFL score again if you have already transmitted a valid TOEFL score to "Send TOEFL Institutional Score Report to" above.
- There is no problem if you submit more than one score. However, we will only use the Appointment Number and the score of the test date you enter through the WEB Application System. (Refer to ② below.).
- We don't accept any inquiries about the arrival of scores.

You can download your Test Taker Score Report (PDF) from your ETS account starting from 8 days after your test date.
- It is possible to change your Appointment Number, Test Date and Test Taker Score Report registered on the WEB Application System within the submission deadline of the department you wish to apply for.
